

**CHANNING BETE COMPANY®, INC.
LICENSE AGREEMENT**

NOTE: THIS LICENSE AGREEMENT ("AGREEMENT") BETWEEN CHANNING BETE COMPANY, INC. AND YOU GOVERNS YOUR USE OF THE LICENSED WORK.

"Licensed Work" is defined to include the presentation titled, *Pandemic Flu Preparedness for Individuals and Families* (CBC item number 64868), including all programming, documentation, and content associated with the presentation that is owned by Channing Bete Company, Inc. and is provided to You (except where a separate agreement is executed by both Channing Bete Company, Inc., and You with respect thereto). Excluded from the Licensed Work shall be any separately identified third-party programming, including Flash® software of Adobe® Corporation. These third-party software programs are not being sublicensed by Channing Bete Company, Inc. as part of the Licensed Work. You might need to obtain copies of these third-party software programs under any required license agreements for operation with the Licensed Work.

1. SCOPE OF RIGHTS

Channing Bete Company, Inc., hereby grants You the nontransferable, nonexclusive, limited right and license to take the following actions:

- (a) Install a single copy of the Licensed Work on a computer system or server owned, leased, or otherwise controlled by You. If You cease to maintain control of the computer system or server, prior to losing control You must completely and permanently remove the Licensed Work from such computer system or server.
- (b) Make available the Licensed Work on any intranet or internal computer network for use by members of your organization and schools within the State of Alabama so long as you provide a conspicuous statement immediately preceding the presentation or link to the presentation which says:

The following presentation has been licensed from Channing Bete Company, Inc. and remains its sole property. Any copying or reproduction of the presentation or its contents, including posting the presentation or any of its contents on the Internet or other computer networks or linking to the presentation or any of its contents from the Internet or other computer networks without Channing Bete Company, Inc.'s written permission is strictly prohibited.

- (c) Use the Licensed Work (in executable, object-code form only) on such computer systems or servers for purposes of educational presentations on pandemic flu.

(d) Use the Licensed Work for purposes of educational presentations on pandemic flu on a computer system or server that is not owned or controlled by you, or is located on premises that are not owned or controlled by You, provided that You:

(i) are solely in control of access to, and use of, such computer system or server at all times during which the Licensed Work is located on such computer system or server; and

(ii) completely and permanently remove the Licensed Work from such computer system or server including any and all storage systems located on such computer system or server, upon relinquishing control of such computer system or server.

Any use, copying, printing, modification, merging, compilation, reverse compilation, creation of derivative works, disassembly, distribution, or other transfer of the Licensed Work not authorized by this Agreement shall automatically terminate Your right and license hereunder and may result in prosecution under Federal copyright, trademark and other applicable law. Without limiting the generality of the foregoing, You acknowledge that extraction, separation, alteration, replication, reproduction, or resale of any illustration, photo, or other graphic component of the Licensed Work as a publishing, clip art, or graphic resource, whether in print, machine-readable, or other form, is strictly prohibited. No part of the Licensed Work may be copied for resale. Upon termination of this Agreement you shall immediately, completely and permanently remove the Licensed Work from any computer system or server on which it is installed.

2. TITLE TO LICENSED WORK

Title to the Licensed Work, including all copies prepared by You, shall be in and remain with Channing Bete Company, Inc., and its suppliers.

The Licensed Work may contain trade secrets of Channing Bete Company, Inc., and its suppliers, and You agree that You shall employ reasonable security precautions to maintain the confidentiality of such trade secrets. As to any source code or system information furnished to You, You agree that You shall at all times prevent disclosure or dissemination of trade secrets embodied therein to any person, firm, organization, or employee, except as necessary to exercise the rights granted to You hereunder. You agree not to "unlock," decompile, or reverse-assemble the binary or object code portions or versions of the Licensed Work, as the terms are generally used in the trade.

Channing Bete Company, Inc., and its suppliers claim and reserve all rights and benefits afforded under federal and international copyright law in all programming, documentation, and content comprising the Licensed Work as copyrighted works.

3. LIMITED WARRANTY

Channing Bete Company, Inc., warrants that, where the Licensed Work is provided on computer disk, magnetic data carrier, or other physical data carrier or media, the medium embodying the Licensed Work will, for a period of ninety (90) days following delivery to You (the "Warranty Period"), be free from material defects in workmanship, provided

SUCH LICENSED WORK IS RETURNED IN ACCORDANCE WITH THE CONDITIONS PROVIDED HEREIN OR (2) IF SUCH REPAIR CANNOT BE MADE OR AN EQUIVALENT REPLACEMENT CANNOT BE PROVIDED, THE REFUND OF THE LICENSE FEE.

4. LIMITATIONS ON LIABILITY

IN NO EVENT SHALL CHANNING BETE COMPANY, INC., BE LIABLE FOR INCIDENTAL, INDIRECT, SPECIAL, RELIANCE, OR CONSEQUENTIAL DAMAGES, OR FOR LOST PROFITS, SAVINGS, OR REVENUES OF ANY KIND, OR FOR LOST DATA OR DOWNTIME, REGARDLESS OF WHETHER CHANNING BETE COMPANY, INC., HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.

THE CUMULATIVE LIABILITY OF CHANNING BETE COMPANY, INC., TO YOU FOR ALL CLAIMS RELATING TO THE LICENSED WORK OR THIS AGREEMENT, REGARDLESS OF THE FORM OF ACTION, WHETHER IN CONTRACT OR TORT, INCLUDING NEGLIGENCE, STRICT LIABILITY, OR OTHERWISE, SHALL NOT EXCEED THE TOTAL AMOUNT OF THE LICENSE FEE.

5. MISCELLANEOUS

The terms and conditions of this Agreement shall remain in effect for **twelve-months from 5/1/09** and may be renewed by mutual agreement of both parties upon termination. Thereafter, the provisions of Sections 2 through 5 hereof shall continue to apply in accordance with their terms, notwithstanding the termination of Your license. This Agreement shall inure to the benefit of, and be binding on, You and Channing Bete Company, Inc., and their respective successors and assigns. You may not assign this Agreement except to a successor to all or substantially all of 1) Your business and properties dealing with the Licensed Work or 2) Your organization's activities (in the case of government agency or community organization). References to "You" and "Your" herein shall include Your organization and any direct or indirect parent or subsidiary company or of any direct or indirect subsidiary company of any such parent company.

This Agreement and the rights and obligations of the parties with respect to the Licensed Work shall be governed by and construed in accordance with the laws of the Commonwealth of Massachusetts, without regard to its choice of law rules. Any action brought in connection with this Agreement shall be brought only in the state or federal courts located in the Commonwealth of Massachusetts of the United States. In any such action, both parties consent to the personal jurisdiction of the federal and/or state courts located in the Commonwealth of Massachusetts of the United States and waive any objections to venue of such courts. Application of the U.N. Convention of Contracts for the International Sale of Goods is expressly excluded.

You return defective media to Channing Bete Company, Inc.. Channing Bete Company, Inc., shall, as its exclusive remedy for any such defects in the media embodying Licensed Work, repair or replace (at its option) the copy of the Licensed Work with another copy without material defects thereof or, if Channing Bete Company, Inc., is unable to provide such a copy, refund the License Fee paid for the defective copy of the Licensed Work.

The foregoing warranty does not cover repair for damages, malfunctions, or service failures caused by (1) actions of any non-Channing Bete Company, Inc. personnel, (2) any conflicts, limitations or any other technical issues with Your hardware, software or any other technology, (3) failure to follow Channing Bete Company, Inc.'s installation, operation, or maintenance instructions, (4) attachment to or incorporation in the Licensed Work of non-Channing Bete Company, Inc. products not supported by Channing Bete Company, Inc., or (5) any factor beyond Channing Bete Company, Inc.'s control, including fire, explosion, lightning, pest damage, power surges or failures, strikes or labor disputes, water, acts of God, the elements, terrorism, war, civil disturbances, acts of civil or military authorities or the public enemy, transportation facilities, fuel or energy shortages, or acts or omissions of communications carriers.

Channing Bete Company, Inc., does not warrant that the operation of the Licensed Work will be uninterrupted or error-free, or that the software functions will meet Your or Your end users' individualized requirements, including but not limited to computer and network processing capabilities. You acknowledge that the Licensed Work gives only basic facts about certain health issues and the information provided in the Licensed Work is not a substitute for a health assessment by a qualified healthcare provider's examination of any person with a health condition or concern, and consideration of laboratory data and other factors unique to the person.

EXCEPT AS STATED IN THIS SECTION, CHANNING BETE COMPANY, INC., AND ITS SUPPLIERS, AND THEIR RESPECTIVE AFFILIATES, SUBCONTRACTORS, AND REPRESENTATIVES MAKE NO WARRANTIES, EXPRESS OR IMPLIED, AND SPECIFICALLY DISCLAIM OTHER WARRANTIES, INCLUDING, WITHOUT LIMITATION, ANY WARRANTY OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, OR NONINFRINGEMENT.

YOU AGREE THAT YOUR SOLE REMEDY AGAINST CHANNING BETE COMPANY, INC., AND ITS SUPPLIERS, AND ITS RESPECTIVE AFFILIATES, SUBCONTRACTORS, AND REPRESENTATIVES FOR LOSS OR DAMAGE CAUSED BY ANY DEFECT OR FAILURE OF THE LICENSED WORK, REGARDLESS OF THE FORM OF ACTION, WHETHER IN CONTRACT OR TORT, INCLUDING NEGLIGENCE, STRICT LIABILITY OR OTHERWISE, SHALL BE (1) THE REPAIR OR REPLACEMENT OF THE LICENSED WORK, PROVIDED THAT

YOU ACKNOWLEDGE THAT YOU HAVE READ THIS AGREEMENT AND UNDERSTAND IT, AND THAT BY USING THE LICENSED WORK, YOU AGREE TO BE BOUND BY ITS TERMS AND CONDITIONS. YOU FURTHER AGREE THAT, EXCEPT FOR SEPARATE WRITTEN AGREEMENTS BETWEEN CHANNING BETE COMPANY, Inc., AND YOU, THIS AGREEMENT IS THE COMPLETE AND EXCLUSIVE STATEMENT OF THE RIGHTS AND LIABILITIES OF THE PARTIES.
